- Strategies to keep you informed


Remember that the best ways to protect yourself from flu are:

Surveillance

US CDC reports that flu activity continued to increase in the US during the week of Sept. 13-19. Widespread influenza activity continues in much of the southern parts of the country, including higher than expected hospitalizations for this time of year. Outpatient visits for influenza like illness (ILI) increased in much of New England.



In Maine, visits to outpatient office settings and hospital emergency departments for influenza like illness increased this past week. There have been some occasional cases of H1N1 detected in students, but no new distinct outbreaks have been identified this past week. (Source: Maine CDC/DHHS, 9/24/09)

Maine EMS, Mid-Coast EMS, Hospitals, and EMS Services in Midcoast Region are hosting a Maine EMS Medivax Training to assist in ongoing preparations for seasonal and H1N1 influenza vaccination planning needs. This program will meet the This training program will meet the educational requirement for Intermediate and Paramedic level licensed providers for administering vaccinations (beyond forced protection) in the state of Maine. Providers that have completed this program may set up a vaccination program within established criteria in house or provide assistance to local programs open to the public, schools, etc. Instructor Coordinators must also complete this program in order to teach future Medivax programs as requested.

Updated News and Guidance

Maine Center for Disease Control and Prevention (Maine CDC) is still actively recruiting H1N1 vaccine distribution (ship-to) sites in Maine. H1N1 vaccine will only be available through state health departments (Maine CDC/DHHS in Maine), and will not be available for private purchase from manufacturers. Priority will be given to hospitals and healthcare practices serving patient populations included in the US CDC H1N1 Vaccine Priority Groups:

- All people from 6 months through 24 years of age;
- Household contacts and caregivers for children younger than 6 months of age;
- Pregnant women;
- Healthcare and emergency medical services personnel; and
- People aged 25 through 64 years who have health conditions associated with higher risk of medical complications from influenza.

Completing the H1N1 Vaccine Provider Agreement is your way of demonstrating interest. If you are a licensed health care provider, and your agency/practice has not registered as an H1N1 Vaccine Provider, then please do so <u>immediately</u>. If you are aware that your agency/practice has already submitted an H1N1 Vaccine Provider Agreement, there is no need to do so again. Additionally, if your agency/practice is part of a larger medical group or practice organization please verify that a Provider Agreement has not already been submitted on your behalf. This is important because there are a limited number of H1N1 vaccine ship-to sites available.

Once the designated H1N1 Vaccine Provider ship-to sites are identified, Maine CDC will take orders for H1N1 vaccine. The H1N1 Vaccine Order Form will be included in the H1N1 Provider Confirmation Packet and online. In the meantime please assess the number of doses needed to vaccinate your priority patient and staff populations.

An accompanying editorial entitled "Respiratory Protection Against Influenza by Arjun Srinivasan, MD; Trish M. Perl, MD, MSc (*JAMA*. 2009;302(17):(doi:10.1001/jama.2009.1494), indicates that masks and respirators should be considered a last line of defense in the hierarchy of infection control; health care workers should be vaccinated against influenza in order to protect their patients and themselves, yet their vaccine rates are low; febrile patients should be quickly isolated and generally masked; "administrative controls" should be implemented; respiratory hygiene and hand washing measures should be strictly adhered to; and febrile health care workers should stay home and be encouraged to by the employers. – Thank you to Dr. Dora Mills for sharing these articles and for her analysis.

Healthcare workers who volunteer to provide vaccinations in school or community clinics must register with **MAINE RESPONDS** (www.maineresponds.org) to receive state liability protection. Maine Responds will verify the credentials of registered volunteers, and names of verified volunteers will be added to a list posted by Maine Emergency Management Agency (MEMA) at: www.maine.gov/mema If the volunteer is not on this list, he or she should not assume that they are covered by the Governor's declaration.



Healthcare workers who will administer vaccine as part of their regular employment are not required to register with Maine Responds, as liability coverage is traditionally provided by the employer for healthcare providers working within their normal scope of practice.

To date, the Maine Responds list contains 392 verified physicians, physician assistants, nurse practitioners, registered nurses, and licensed practical nurses. Combined with the Maine EMS list, we have over 700 verified volunteer vaccinators identified statewide.
