New Mitigation Planning Resources for Hazard Mitigation Assistance

Mitigation Planning and Hazard Mitigation Assistance (HMA) would like to announce the availability of two mitigation planning resources. Additional information and resources are provided on the FEMA Mitigation Planning website at <http://www.fema.gov/plan/mitplanning/index.shtml>

Mitigation Planning for Local and Tribal Communities, FEMA IS-318.

In December 2011, an updated independent study course was released to support local and tribal mitigation planning. IS-318, Mitigation Planning for Local and Tribal Communities, is a course offered by the Federal Emergency Management Agency (FEMA). The goals of this course are to:

- Assist participants in undertaking the hazard mitigation plan development process. This plan will meet the needs of your community and fulfill the requirements for local plans, as described in 44 Code of Federal Regulations (CFR) §201.6, or for Tribal plans, as described in 44 CFR §201.7.
- Help federal and state plan reviewers interpret the regulations to inform the review of local or Tribal hazard mitigation plans.

Local Mitigation Plan Review Guide

The *Local Mitigation Plan Review Guide* (released October 1, 2011) is available now, and it contains several significant

changes from the current local mitigation planning guidance:

- Stronger emphasis on the Mitigation Strategy and Implementation;
- Simplified to describe only the regulatory requirements;
- New Guiding Principles and Intent statements support regulatory requirements; and
- New Plan Review Tool to replace the existing Crosswalk in a simplified format and communicate implementation of the plan as well as improvements to the plan.

The revised *Local Mitigation Plan Review Guide* is available for any State to use as of October 1, 2011. Implementation will be phased over the course of a year and the *Local Mitigation Plan Review Guide* will become effective on October 1, 2012 to allow stakeholders at the State and local level to prepare for the change.

Many communities are presently in the process of developing local mitigation plans, and all communities currently reference the *Local Multi-Hazard Mitigation Planning Guidance* (June, 2008) and the corresponding Plan Review Crosswalk.

In FY12, new guidance will also be released for local plan developers. During this time, it is important to remember that the mitigation planning regulations have not changed; the plan requirements remain the same.

Psychological First Aid (PFA) Training Program Overview

This program is a six hour, interactive, face-to-face training that provides public health professionals, emergency responders, and natural community helpers without former mental health education with the concepts and skills associated with psychological first aid. Additionally, this training is applicable to public health settings, the workplace, the military, mass disaster venues, and even the demands of critical incidents, e.g., dealing with the psychological aftermath of accidents, robberies, suicide, homicide, or community violence.



What is PFA?

A full-scale public health response to disasters must attend to both the physical and mental health needs of affected groups. The latter set of needs is especially important because most authorities agree that far more individuals will report psychologically-related complaints than will report physical symptoms directly stemming from the injury-causing agency or event. Because a large scale emergency will overwhelm existing mental health response resources, psychological first aid — the provision of basic psychological care in the short term aftermath of a traumatic event — is an important skill set that all public health workers, emergency responders and natural community helpers should have.

Target Audience

Public Health workers, emergency responders, mental health and substance abuse providers, healthcare professionals, social workers, and others interested.

Specific Topics to be covered in this PFA training:

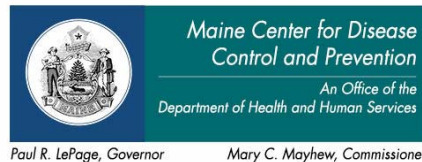
- Basic communication techniques for PFA
- Resiliency: new emphasis
- Common mild psychological and behavioral reactions after a disaster
- Severe, potentially incapacitating psychological and behavioral reactions after a disaster
- Basic stress management for disaster survivors
- Reducing risk of adverse outcomes
- When to refer for further mental health support
- Self-care for disaster workers

Notice: FY 2013 NFA or EMI Courses

FEMA is moving toward eliminating the use of the Social Security Number (SSN), where possible, when applying for any FEMA training.

Beginning on April, 15, 2012, individuals, including FEMA employees, applying for certain National Fire Academy (NFA) or Emergency Management Institute (EMI) classes will be required to register using the Center for Domestic Preparedness (CDP) Training Administration System (CTAS) and obtain a CDP Student Identification (SID) number if they do not already have one. This number will be used in place of the SSN on your application. You will be asked to provide your SSN to register in CTAS but this will be phased out later this year.

Which courses does this process impact?

1. NFA or EMI courses at NETC (including the NFA 2 day on-campus state weekend courses) – Course letters E, I, P, R, T, W
2. EMI courses at the Noble Training Facility – Course letter B
3. Courses delivered through the NFA (NFA Sponsored 10-day and 6-day) or EMI off-campus programs Course letters L, N, S
4. For any of the above courses delivered after October 1, 2012.
5. All other courses (Course letters C, D, F, H, K, O, Q, Y, IS) are not impacted by the process.

How do I obtain my FEMA Training Identification Number (FTIN)/CDP Student Identification (SID) number?

Step 1: To register, go to <https://cdp.dhs.gov/elms>

Step 2: Click on the "Create Account" button on the left side of the screen.

Step 3: Follow the instructions and provide the necessary information to create your account.

What do I do with this new FTIN/CDP SID number I've been assigned?

The CDP SID number should be used in place of the SSN on your General Admissions Application (FEMA Form 119-25-1) and the General Admissions Application Short Form (FEMA Form 119-25-2).

Why is it important to register in the CTAS?

Any applications for FY 2013 NFA or EMI courses that do not include the training registration number will not be processed until CDP SID is provided.
